

### **GENERAL COMMENTS**

At the end of the 2009 WIQP, I was not sure if the record we set in 2009 for the most entries to date was due to WIQP continuing as one of the most popular state QSO parties, OR was it due to the ARRL's having done the "Year of the State QSO Party" event for all of 2009? After finishing the data work this year, I find we did set another new record for the number of entries. However, I am not sure this is enough evidence, as one year does not a trend make. I suspect we should wait till WIQP 2011 is over to give us one more data point, before we draw any conclusion. I do believe that the data I looked at this year will support the idea that interest in WIQP continues. I would hope that this continuing interest is a direct result of how we conduct WIQP each year.

2010 was an interesting year. Four new records - besides the new WIQP record in the number of entries, I found new records in the Single Operator Fixed, the Single Operator Mobile, the Multi Operator Multi Transmitter Fixed categories, and a new record for the WI Club Competition among the 30 clubs that entered the WI Club Competition. Lastly, and the bigger surprise to me, was the Beginner category, which is new this year. The Beginner category had 7 entries, one of which was actually a multi operator entry. WIQP and contesting in general must still be providing interest, which is very encouraging. Thanks to all of you for that.

WIQP 2010 got 304 entries – a 4.5 percent increase over 2009's 291 entries, which itself had showed a 8.6 percent increase over 2008's entries. We again saw an increase in the number of electronic logs submitted. Of the 304 entries received, 253 were electronic. Paper logs numbered 51 this year, about the same as last year. An interesting item related to paper logs – of the 51 submitted, 23 of them were printed, which means they could have been submitted electronically. Perhaps we are not doing our job in making the procedure as easy as it really is for doing electronic submission. We can accept most any printed, text type format. Attaching it to an email OR sending it as a printed page works fine most times. We would like to work with you to get you comfortable with doing electronic entries. Let us know how we can help?

Last year I had some positive comments about the overall number of contacts WIQP generates in seven hours. Last year it was 39,339 total in WI and out. This year total in and out is 46,784 contacts – up 18.9 %. In Wisconsin, for 2010, I found 35,701 contacts, broken down thusly - 15,814 CW and 19,887 phone contacts. Out of the state I found 11,083 contacts - 7,384 CW and 3,699 phone contacts. Band conditions, or more activity, or continuing interest? You bet.

We had 159 WI entries, and 145 out-of-state entries this year, which is a reversal from last year, when we had 139 WI and 151 out-of-state entries. When I looked back at 2005 to present, I found: 2005 had 134 WI and 99 out; 2006 had 145 WI and 95 out; 2007 had 160 WI and 103 out; and 2008 had 156 WI and 112 out. So the actual reversal was last year. I honestly believe that was the result of the ARRL Year of the State QSO Party event in 2009.

We were a bit short of all 72 WI counties being on this year, for the first time in many years. We had 69 WI counties on, although there is a quirk in that number. Actually, I found 69 in all the logs but one. That one log showed one contact with RUSK with an unassigned call sign, according to QRZ.com. However, if it were actually a miscopied call sign, like I believe it was,



it would actually be a valid Missouri contact. Besides, one wonders how only ONE Rusk contact was made across 46,784 contacts. Hence, 69 WI counties are going into the official results. In summation, the counties of FLORENCE, IRON and RUSK do not appear anywhere in the logs. All 50 states and 7 Canadian Provinces were in the logs. DX logs were received from Czechoslovakia, Germany, the Netherlands and Russia

We usually have seen around 60 WI counties as a maximum number for the top out-of-state stations. This year, as you will see from the table below, we had a number of stations that exceeded that amount. I include the WI top 20 for comparison.

Since I was mobile this year, I do not really have a feel for the bands or the activity. Hence, I will rely on the soapbox comments for some insight. I believe they tell the story. The overall best one I found is W9PN's – "the good and the bad this year was that the bands were much improved over last year. Bad for cloud burning and working within the state, good for picking



up distant multipliers......40 and 80 meters went long early .....Dane and Fond du Lac Counties seemed to be the most prolific."

#### **WEATHER**

When I said last year that it was "perhaps the best weather that I can remember for a WIQP event, for many of the years I have been Chairman," I was wrong. This year was definitely the best one. When I did my usual stop at a few weather web sites around the state, prior to the contest, to see what conditions looked like, all I found was forecasts for temps in the 50's and part sun to full sun. I will remember this year very well, as #3 son and myself did my first ever mobile operation - AND - we had shirt sleeve weather for the entire 9 county trip we took. Being able to keep the doors of the van open while setting up and operating was great. I am not the only one that enjoyed the weather either. I found other comments that support my feelings, such as - W9HB "the weather was grand for a 395 mile cruise about Wisconsin," or K8IR op of NG9T "I did not think the weather ... could be better than in 2009, but it was," or K0PC " a beautiful day for drive through Wisconsin. The thermometer in the car said 60F and I thought RF was getting into it. But no, it was a glorious spring day," or KF9AF "glad it was not too nice outside," or K9EAM "possibly due to the unseasonably warm weather." I think it is best summed up by the comment of W0ZQ "thanks for ordering the 65 degree weather this time."

#### **CONDITIONS**

Soapbox comments indicated that conditions were great too. Comments like – AE1T "lots of activity," or WA1UJU "thanks for arranging great conditions on 40 this year," or N2CU "great 40M activity and solid signals on 40 and 80," or W2UDT "20M was good compared to last year," or DL3GA "finally 20 was open for a while, rather than closing after one hour," or KJ8O "had a great time with the short skip 40M band opening," or KV8Q "sounded like skip was short up in Wisconsin as I heard lots of in-state Qs on 40," or N9AW "conditions were very good all the way around on HF," or KA9FOX "thought conditions were great," or W9HB "what great band conditions. QSO rate 110 per hour," or K0PC "I thought the bands were in very good shape."

#### **ACTIVITY**

It also appears that activity was high, based on comments such as – W1END "great activity. Lots of non-mobiles," or K1QO "great participation by the mobiles," or W2UDT "thanks to all the mobiles who kept the counties coming," or VE3CRU "very intense 7 hour contest," or KV8Q "lots of activity, both mobile and fixed stations all over the place," or N9AW "thanks to all of the non-WI stations that participated," or W9ET "this contest is amazing – the level of activity," or KA9FOX "participation was excellent," or

KC9POO "who would have thought that Columbia County was so rare to cause pileups," or K0PC "lots of activity right from the start." Best summation comment would be by NG9T "I never took my hands off the keyboard for the seven hours."

To help me gauge activity, I took a brief look at scores for several years. When I looked at the top SOF operators in Wisconsin, same station, over 2 years, I did find an improvement in score totals. To me that is because we had more stations available than in 2009. Then I looked at



multipliers. I found them, on average, pretty much the same. Not sure if that is due to more stations at the other end or not, or band conditions, or something else. Next I looked at the out-of-state SOF operators. Overall, their scores were down just a bit, but here the multipliers took a bigger dip than the scores, in my view. This might relate to our not having all 72 counties on this year, for the first time in a long time. Some of the same stations, year over year, did do better, which I attribute to better band conditions.

To further gauge activity, I also compared our entry categories year over year for WI stations. This year, over 2009, we did get a few more in the SOF, SOM and MOF categories, while the SOT, MOM and MMM went down a tad. All of these improvements were better than we saw in 2008. I think I can safely say that is probably due to the increased number of entries we saw this year.

Are we seeing continued interest? Is there more activity by previous participants or is there more activity by new stations coming aboard? With increased entries for the last two years, I decided to look into "new" calls - meaning, how many new calls were present the last 2 years, to see if interest was indeed continuing. I wanted to see if the increases we have seen in the last 4 years were mainly due to more of the "regulars" or if in fact, we were seeing more new call signs each year. In order to do that, I went back and pulled the call sign list from 2007, 2008, 2009, and 2010. I compared each to the previous year. What I found surprised me. In 2009 there were 158 "new" calls that had not been on the list in 2008. This year I found that we had 166 "new" calls that were not on the list in 2009. I went one step further. Of the 166, 39 were repeat calls, having been on in one or more previous years, going back to 2006. I know from doing this data work for so many years now, that a lot of the regular stations do not or cannot participate each year. These 39 were what I would call "regulars." They operate when they can. That means that 127 calls, of the 166, were totally "new" to WIQP in 2010. I am sure that if I did the same for the 2009 list, I would probably find the same thing. While I am not sure of the significance of that data, it does sort of tell me that each year we are seeing new calls participating. A number of those new calls are recently licensed, which also tells me that contesting is still attracting newcomers. Maybe that is why the Beginner category got seven entries? That encourages me.

#### **MOBILE STATIONS**

Over the years, our mobile operator total has been oscillating up and down, peaking at 36 mobile ops in 2004 and 2006. Last year, during the ARRL event, we saw only 22 mobiles take to the WI highways, the worst since 2002 when there were 23 (I only went back to 2001 for the data). This year I am happy to report, we have 25, an increase, however slight. I know that two of our "regular" mobiles did not participate in WIQP this year, and a third mobile op did a multi operator fixed operation this year.

(Just a side note. I think that perhaps Rusk and Iron were missing because one of the "regulars" that last year traveled thru both of them did not participate this year AND Florence was perhaps missing because of a route change by one of the mobiles, who last year visited FLO. Just a thought). Since I did a mobile operation for the first time ever, under the best of conditions, I believe I can now understand why the total oscillates. Besides the bouncing around for 7 hours, I



am sure the weather plays a big part. I know this was a banner year for some of the mobile stations. A lot of them achieved personal highs. Of the 25 that entered, 20 of them were Single Operator Mobile, 3 of them were Multi Operator Mobile, and two of them were Multi Operator Multi Transmitter Mobile. The two Single Operator Technicians are included in the 20.

The two tables below are a look at the top ten Single Operator stations by SCORE, both in and out of Wisconsin. With the WI table, I included the entry classes of the Single Operator stations, to give you an idea of the mixture of mobile versus fixed for WI, as I have done in past years:

### **RESULTS**

The new Beginner category had seven entries, as I noted above. I want to encourage each of the seven to continue on in both WIQP and contesting in general. I want them to also get thanks from the rest of us for participating. There is no overall winner, as each one will receive their own certificate. To highlight, I provide the following list - as a Single Operator entry, from Columbia County we have Brad Schack, KC9POO, from Grant County we have Nathan Manwiller, KC9LVU and Dennis Schaal, KC9OTY, from Juneau County we have Howard Fischer, KC9IVJ, from Milwaukee County we have Charles Dellis, W9WLX and from Waukesha County we have Vincent Mulhollon, N9NFB. As a Multi Operator Fixed entry, from a Vernon County dairy farm, we have the trio of Ralph Hendrickson, KC9LBO, Nicole Hendrickson, KC9NHQ and Kathryn Swenson, KC9OYG. Congratulations to all of you. Hopefully we will continue to see your entry in future years, as well as in the lists of the many contests. Welcome.

The 2010 plaque for highest scoring Single Operator in Wisconsin goes to first time winner, James Callow, K8IR, who operated NG9T, the club call of the Tri-Cities Contest Club, as a WI mobile. Jim lives in Menomonee, Michigan. I think his soapbox comments tell the real story – "I did not think the weather or conditions could be better than 2009, but they were. I never took my hands off the keyboard for the seven hours. Thanks to all who called in. And special thanks to my driver, Eric, KG9GH. Great to have in-state propagation on 40." So you can get a picture of what doing a mobile entry is all about, I thought this year it would be interesting to trace a mobile route. I used the NG9T mobile 18 county route. James started this year, like last year, in Door County, ran down into Manitowoc County, then proceeded to head across the top of Lake Winnebago, down the west side of the lake to Fond du Lac County, then west to Marquette



County, and then began a northerly trek from Waushara County north to Forest County, where he ended. His "in-county" times ranged from 6 minutes to a high of 41 minutes. For those interested, here is the breakdown – DOO 6 mins, KEW 13 mins, BRO 28 mins, MAN 30 mins, CAL 18 mins, OUT 14 mins, WIN 25 mins, FON 14 mins, GRL 22 mins, MRQ 18 mins, WSR 31 mins, POR 41 mins, WAP 20 mins, SHA 37 mins, MEN 27 mins, LAN 12 mins, OCO 17 mins and FOR 10 minutes. Last year when James did his MOM operation, he only did 11 counties, and spent up to an hour in some of them. Obviously, I guess he planned a better setup this year, which put him in the 2010 Wisconsin's Best Single Operator Winner's Circle. He did 832 CW contacts, low power. He worked 28 WI counties, 40 states and 2 Canadian Provinces, for 70 total multipliers. His final score total 183,720 points. And that puts him into the record books, beating out NE9U who set his record in 2009 with 172,615 points. He has a website (K8IR.com), that shows the truck they operated from. I know I must have passed him since we were both in the same county at the same time – although I did not work him. Probably when my radio went berserk? Congratulations James on breaking the Standing Record and enjoy your plaque.

The 2010 plaque for the highest scoring Single Operator outside of Wisconsin goes to another first time winner, Paul Kirley, W8TM, from Cincinnati, OH. Paul has been a participant in WIQP since 2004, during which he participated as a QRP entry. He came close in 2007, achieving second place. This year he did one better. He is the third QRP operator to win WIQP since we put the power multiplier in place in 2001 – W3BBO in 2001, N0UR in 2005 and now W8TM in 2010. Another interesting QRP fact – this year our first and third place positions were QRP. I understand that doing QRP is a REAL CHALLENGE, based on the soapbox comment from Tom, W9VBQ – "I did not do as well as I would of liked but being QRP I had to fight for every Q I got. Except when there was a pile up, I had no problem with making Qs. In pile ups, I had to wait until all the other calling stations had made contact before I could. That made for a very long 6 hours." Tom is not the only one to tell me that either. Five watts can be a challenge, however, Paul took the challenge and beat the pack. Paul did 157 CW, and 43 phone contacts, with 58 WI county multipliers, for a total of 41,412 points. Not a new out-of-state record though. Congratulations Paul. I know you will enjoy your plaque.

Our 2010 plaque for the Wisconsin Club Competition goes to a repeating winner – the Fond du Lac Amateur Radio Club. This is their eighth win. Their 22 operators entering the Club Competition scored a total of 977,185 points. Amazing. Based on their 2009 total score, that is an almost 89 percent increase. Based on their previous standing record set in 2003, that is an almost 37 percent increase. Obviously, they set a new standing record. At almost a million points, I wonder if it will ever be broken? Congratulations to all twenty-two of you. Enjoy your plaque.

The Single Operator Fixed category was won by Scott Neader, KA9FOX, of La Crosse. He made 408 CW Qs and 330 phone Qs with 56 counties, 44 states and 5 Canadian Provinces, for a total score of 180,495 points. Scott did set a new standing record for SOF, surpassing the WE9V record set in 2002. Congratulations Scott.



The Single Operator Technician category was won by Brian Long, KB9LRD. This is Brian's 5<sup>th</sup> first place in a row. He always operates as a mobile, in SOT. This year he traveled through 15 counties, making 232 phone Qs, while working 21 counties, and 1 state, for a total score of 14,156. Congratulations to Brian on your five-peat.

The Multi Operator Fixed category was won by the Hidden Valley ARC's team of N9BIL, NN9K and N9YPN, who in past years had operated as a multi multi mobile entry under the NN9K callsign. They decided to do a fixed portable operation this year. It worked. As K9WM, the Green River Valley ARS of East Moline Illinois call sign, they won, making 310 CW Qs and 176 phone Qs with 65 counties, 41 states and 2 Canadian Provinces, with a total score of 129,452 points. Not a new standing record. NN9K does hold the multi multi mobile standing record they set last year though. Congratulations to Timothy Rogerwall, N9BIL, Peter Beedlow, NN9K and Anthony Padavich, N9YPN.

The Multi Operator Mobile category was won by the WX9EP team, representing the Mississippi Valley ARA. They made 237 phone contacts with 39 WI counties, and 14 states, while traveling thru 13 WI counties. Total score was 25,841.5 points. Congrats to Eric Papenfuss, WX9EP, and Christopher O'Hearn, KC9DGP.

The Multi Operator Multi Transmitter Fixed category was won this year by W9EAU, the club call sign of the Eau Claire ARC, for the third year in a row. Their 13 operators made 579 CW Qs and 982 phone Qs, working 66 counties, 49 states and 7 Canadian Provinces, for a score of 391,620 points, which set a new standing record. They bested the W0AIH previously held 2002 standing record for this category. Congrats to Paul Bittner, W0AIH, Mark Seyffer, KB9S, James Staatz, KI9H, Steven Bluem, KA9OMY, Kirk Dahl, N0KD, Roger Wise, KI0F, Mark Marusik, N9FE, David Voss, KB9WPC, Ronald Anderson, W9RMA, Jonathan Case, KE9KW, Catherine Seyffer, K9KTT, Rolf Nestingen, KG0KM and Nathan Peterson, KC9FEI.

The winner in the Multi Operator Multi Transmitter Mobile category is me, K9KR, a first time mobile operator. Son Jeff and I scored 16,155 points, based on multipliers of 32 counties, 9 states and one Canadian Province, while traveling thru 9 counties, doing 9 CW and 167 phone contacts. Thanks Jeff, KC9NPZ.

#### **STANDING RECORDS 2010**

I thought I would include the current standing records with this report. I changed it from previous versions, in that, I removed the two categories we retired way back in 2001. This list represents the current "continuing" standing records. It does not include the Beginner category because of the limits for participation in that category – you can only enter it twice (in succession), which does not fit in with a "continuing" standing record list concept.

We are considering changing the start time to an hour earlier in 2011, because of the increased activity we are seeing from DX type stations, due to improving band conditions. If you care to comment, please do so

#### **COMMENTS NEEDED**

The West Allis club had been having some discussions on CW, specifically on the use of CW DECODERS. With the increasing speed of computers, and much better programming, there is a question as to how machine copy of CW will affect WIQP. We wonder if CW operators who copy code in their head (analog?) will have a problem with a person who cannot copy code, then sending in an entry, and possibly winning a certificate or plaque, i.e. winning over a person who can copy CW without a computer. We would like to see CW participation continue, as that is a big part of WIQP each year, especially by mobile stations. We do not want to discourage participation, but we are wondering if you feel there needs to be a new category, or a separate way of listing those machine copied CW entries - OR if you feel that no changes are needed. We especially need to hear from CW operators. Please be honest.
